

Terms and Conditions – Easter Giveaway

1. Organizer

2. Entry Period

The contest runs from Good Friday [April 3, 2026, 12:00 a.m. CET] to Easter Monday [April 6, 2026, 11:59 p.m. CET]. The time at which the order is completed in the organizer's online store is decisive.

3. Participation

All customers who place an order in the organizer's online store during the period specified above and reach a minimum order value of €200 are automatically entered into the contest. The minimum order value refers exclusively to the value of the goods in the order and does not include shipping costs. Each order counts as one entry into the contest. Multiple orders result in multiple entries.

4. Exclusion of Orders

The following are excluded from participation:

- Orders with a merchandise value of less than €200, as specified in Section 3
- Canceled orders- Orders that have been returned in full or in large part (see also Section 15)
- Orders in which abuse or manipulation is detected

5. Eligibility to Participate

Natural persons aged 18 or older who are residents of the European Union are eligible to participate. Employees of the organizer and their relatives are excluded from participation.

10. Disqualification of Participants

The organizer reserves the right to disqualify participants from the contest in the event of violations of these terms and conditions, false statements, or attempts at manipulation.

11. Early Termination or Modification of the Contest

The organizer reserves the right to adjust, modify, or terminate the contest early at any time for good cause, provided that this becomes necessary due to circumstances beyond the organizer's control.

12. Liability

The organizer shall not be liable for technical malfunctions, outages of the online store, or other disruptions that could affect participation in the contest, unless such issues were caused by willful misconduct or gross negligence.

13. Governing Law

The laws of the Federal Republic of Germany shall apply, excluding the UN Convention on Contracts for the International Sale of Goods.

14. Legal Remedies

Legal remedies are excluded.

15. Return of Orders / Handling of Prizes

If, as a result of a cancellation, return, or other reversal of the order, the minimum order value required for participation as specified in Section 3 is no longer met, the claim to the prize is forfeited. If the prize has already been handed over or shipped, the participant is obligated to return it to the organizer (for example, as part of a return). If returning the prize is not possible, the organizer reserves the right to offset the value of the prize against the refund amount for the order or to deduct it from the refund amount.
